**NOTICE AND STATEMENT OF RECEIVER
(Subsection 245(1) and 246(1) of the Bankruptcy & Insolvency Act)**

Take notice that:

1. On March 22, 2022, the undersigned, BDO Canada Limited, was appointed as Receiver with respect to certain property of Centre de Collision Nord-Ouest Inc. / North West Collision Centre Inc. (the “Debtor” or the “Company”), an insolvent person, that is described below:

Leased equipment and other assets located at 738 Rue Victoria, Edmundston, New Brunswick

2. The undersigned became Receiver with respect to the property described above pursuant to an appointment by the Debtor’s primary secured lender, the Royal Bank of Canada (“RBC” or the “Lender”), subject to the following security:
 - a) A General Security Agreement dated August 13, 2018 over all of the Company’s present and after-acquired personal property; and
 - b) A Master Lease Agreement dated September 4, 2018 together with all inventory and equipment now or hereafter acquired by the Company and financed by the Lender.
3. The undersigned attempted to take possession of and secure the property described above on March 22, 2022, however possession of the assets remains with the landlord, Francine and Yves Dion and Francoise and Francois Gagnon (“Dion and Gagnon” or the “Landlord”). The Receiver has arranged for insurance coverage for the assets in the possession of the Landlord.
