The Receiver gives notice and declares that:

The primary operating entity is 908593 Ontario Limited ("908"). The operations of 908, together with certain other entities operate various retail and diesel gas stations and a fleet member royalty card program ("Eagle Fleet Services") used by in excess of 1,250 customers at gas stations located in Canada and the U.S. The Receiver advises that its review of the books and records (the "Records") of the Companies is ongoing and to some extent limited for certain of the entities as outlined herein.

2. On September 30, 2019, BDO Canada Limited was appointed receiver (the "Receiver") of the assets, undertaking and properties (collectively, the "Property") of the Companies pursuant to an Order (the "Appointment Order") of the Ontario Superior Court of Justice Commercial List (the "Court"). A copy of the Appointment Order and future reporting and court materials in these proceedings can be found at the Receiver's website:

3. The Receiver was appointed under section 243(2) of the *Bankruptcy and Insolvency Act* and section 101 of the *Courts of Justice Act*.



- 4. The Receiver took possession and control of certain of the Property described above on September 30, 2019 with the exception of the Property of 1254044 Ontario Limited which operates the Sarnia Service Centre at 5906 Oil Heritage Road in Wyoming, Ontario ("Wyoming").

The Companies are involved in the following business activities (although not all activities are effected through each entity): Retail gas stations and convenience stores, semi-trailer truck diesel gas stations, fast food restaurants, real estate holdings, and the administration of a commercial gas fleet services finance card ("Eagle Fleet Services"), which includes in excess of 1,250 customers.

6. The Receiver is continuing to review the Companies' financial records that are in its possession to understand the current financial position of the Companies. The Receiver does <u>not</u> believe the Companies' internal financial records are complete or up-to-date. Based on discussions with senior management, it is understood that there is no centralized internal reporting system to track the largest component of the 908 business, namely the Eagle Fleet Services loyalty card program. Eagle Fleet Services reporting has historically been generated manually on a monthly basis by one individual with external compilation of the records on a quarterly basis.



The Receiver will continue to review the records and will provide any further updates on the Receiver's website noted above.
